

Technical Abstract Submission Deadline (Oral/Poster): June 6, 2024

We are seeking abstracts that feature **emerging research and innovation in methods-based content.**

Submission Guidelines

Abstracts will be sought in the following focus areas for both poster and oral formats:

- Al and Food Systems
- Nutrition
- Food Safety
- Plant-Based Proteins
- Instruments
- Regulations and Traceability

Submissions must include the following:

- Justification
- Objectives
- Materials and Methods
- Results and Conclusions

The following elements are also considered:

- Soundness
- Importance to the Advancement of Cereal Science
- Timeliness of the Subject Matter
- Clarity of the Presentation

Abstracts are limited to 400 words. Edit and proof your abstract before submitting it. Ensure all authors and affiliations were accepted to the form.

Publications of tables, charts, and graphs posted at the annual meeting by anyone other than an author or presenter is prohibited unless a release has been requested and received in writing from an author or presenter.

Use of company names is prohibited in titles of presentations. Use of registered or proprietary names or trademarks of ingredients, instruments or other items is discouraged in titles except when the name is so intimately connected with a particular process as to be synonymous with the method and results. Abstracts should minimize use of proprietary nomenclature or company name as well.

Evaluation and Acceptance Notification

Presentations for the Chemistry, Quality, and Technology Conference are based on a peer-review process with the same requirements used for review of submissions to Cereals & Grains scientific publications. All proposed abstracts will be evaluated based on the above submission requirements and inclusion of the required elements.

Accepted submissions will then be designated as an oral or poster presentation and placed in an oral session or poster format based on the submission keywords.

Final program selections and notifications will be made in July and acceptance notifications will be delivered via email to all submitters. There are a limited number of slots available for oral presentations; if your submission is not accepted for a technical talk, it will be moved to a poster presentation.

Designated presenting author (of either an oral technical or poster) must be registered for Chemistry, Quality, and Technology Conference and pay the fee by **September 6, 2024**. Failure to register will result in your abstract being withdrawn from the meeting.

Attendees from Outside the United States

If you require a visa to attend Chemistry, Quality, and Technology Conference do not wait until you receive notification that your abstract submission has been accepted before applying for a visa. If your abstract presents new information and follows the requirements and acceptance criteria, it will most likely be accepted or accepted with revisions in poster or oral format.

Customized visa invitation letters can only be issued to confirmed registrants including those who have paid the meeting registration fees), have submitted an abstract, or are otherwise presenting. When you register for the meeting, you will receive a confirmation email with a link to auto-generate a customized visa invitation letter. If you are unable to register early enough to begin the visa process and have submitted an abstract, please complete the <u>invitation letter request form</u>. Invitation letters generated using the request form are identical to the letters created when registering, however they are manually created and may take up to 5 business days to be processed.
